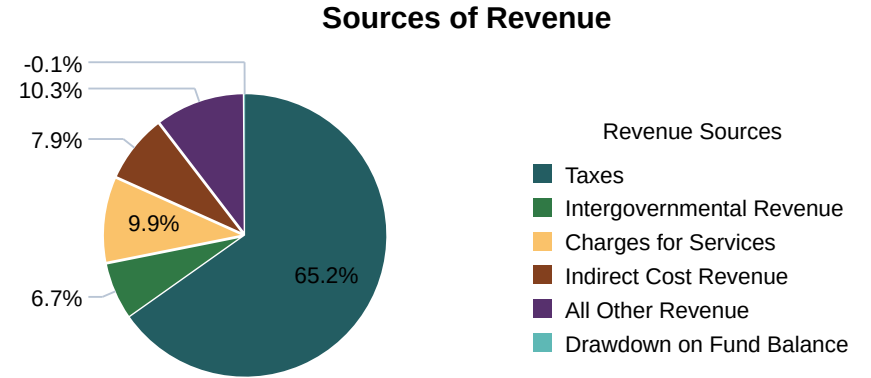

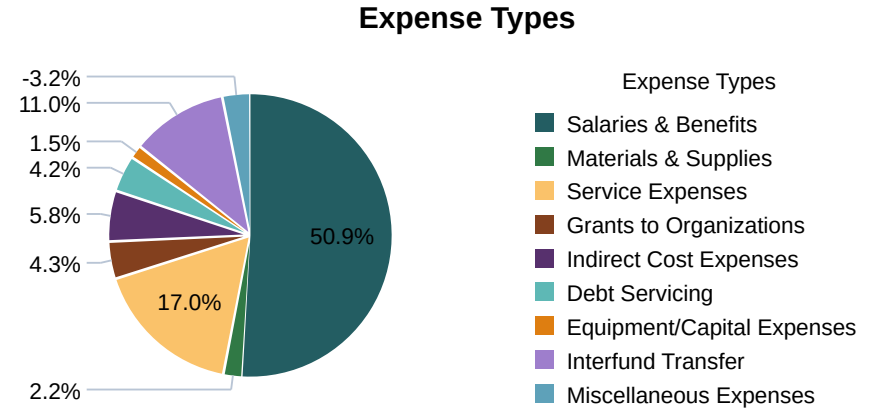

Key General Fund highlights, factors, and assumptions:

1. County departments initially requested nearly \$10 million in cumulative spending increases for 2026, bringing the total proposed expenditures to \$232 million and resulting in a projected \$31 million deficit, which would have required a tax increase of more than 25% to close.
2. The budget proposal introduced in November reduced total expenditures from \$232 million down to \$225 million, lowering the projected tax increase needed to approximately 15%.
3. Through continued coordination with County departments and the Courts, along with additional cost-containment measures, this revised proposed budget further reduces total expenditures to less than \$222 million.
4. The revised budget reduces the overall costs of County government in 2026 compared to 2025, despite continued inflationary pressures and rising health care costs.
5. In place of a 15% tax increase, the revised budget includes a 9.75% (0.817 mil) tax increase for 2026.
6. Under this revised proposal, the projected ending General Fund balance for 2026 is approximately \$13.9 million.
7. Collective bargaining is ongoing for contracts expiring at the end of 2025. The budget includes a 2.95% cost of living increase for all non-union employees.
8. County departments requested seven new full-time positions for 2026. None are included in the proposed budget.
9. The budget includes \$549,600 for County guarantees related to the Harrisburg Incinerator debt in accordance with the Harrisburg recovery plan following the 2023 refinancing.
10. An additional \$2.16 million is included to cover the 2026 ash disposal costs for the Harrisburg Incinerator, bringing the total County obligation to approximately \$11.59 million.
11. No funding is included for the County guarantee on the Harrisburg Parking Authority debt. The guarantee has not been drawn upon since the January 1, 2022 payment.
12. A \$2 million vacancy adjustment is included to reflect the salary and benefit savings achieved by holding positions vacant.
