REQUEST FOR INFORMATION (RFI)

SCOPE: Dauphin County, Pennsylvania, operates the Dauphin County Prison. For purposes of this RFI, the County and Prison are synonymous. Dauphin County Prison (DCP) is seeking information to offer comprehensive reentry services aimed at supporting individuals as they transition back into the community. This RFI focuses on gathering details about providers who can deliver reentry services, including transportation, credible mentoring, housing assistance, wrap-around transitional services, employment support, and life skills development. These services aim to reduce recidivism, facilitate successful reintegration, and improve long-term outcomes for formerly incarcerated individuals.

Responses to this RFI are voluntary and do not constitute a request for proposals, quotations, or bids. There is no obligation or commitment from DCP for future action, contracts, agreements, or acquisitions based on this RFI. We will not pay for the preparation or submission of responses, which will be used solely for planning and market research.

To the extent possible, please submit non-proprietary information. Any proprietary details should be clearly marked and will be safeguarded according to Dauphin County Prison regulations. Responses will not be returned.

BACKGROUND: Dauphin County Prison's mission is to serve our community by providing a safe environment that supports personal growth, rehabilitation, and successful reentry. DCP recognizes the need for comprehensive, integrated services to address the multifaceted challenges individuals face upon release. DCP values partnerships with external providers who share our commitment to offering wrap-around reentry services that support transportation, stable housing, mentorship, employment, and essential life skills.

PURPOSE: This RFI seeks information about your organization's capacity to deliver comprehensive reentry services.

GOAL: To ensure that incarcerated individuals at DCP are supported by a continuum of reentry services that addresses critical needs in transportation, mentorship, housing, transitional support, employment, and life skills, enhancing chances for successful reintegration.

SOLUTION APPROACH: Identify providers and service models that adhere to industry standards for reentry services, including mentorship credentials, transportation solutions, structured housing assistance and coordinated wrap-around support for a seamless transition back into the community.
