A Temporary Felony Want Record may be entered to establish a "want" entry when a law enforcement agency needs to take PROMPT ACTION to apprehend a person (including a juvenile) who has committed, or the officer has reasonable grounds to believe has committed, a felony. The individual may seek refuge by fleeing across jurisdictional boundaries while circumstances prevent the immediate acquisition of a warrant. A warrant for the arrest of the individual must be obtained as soon as possible and thereafter, the TEMPORARY FELONY want record must be canceled and a permanent wanted person record must be entered.

## A TEMPORARY FELONY WANT RECORD WILL BE AUTOMATICALLY REMOVED FROM THE FILE AFTER 48 HOURS!
