The charges are included in the above Municipal Rates if applied uniformly to every property; however, some municipalities randomly apply such charges of varying rates. Municipalities where this occurs are identified by a letter after above basic municipal tax rate. They are H (Hydrant); L (Street Lights); S (Sewer); T (Trash), and may not be included in the above rate. Contact the Tax Collector or Municipal Office for more information on a particular property.
