A RESOLUTION OF THE COUNTY OF DAUPHIN, PENNSYLVANIA APPROVING THE ISSUANCE BY THE PUBLIC FINANCE AUTHORITY OF BONDS ON BEHALF OF AERO HARRISBURG, LLC

WHEREAS, Aero Harrisburg, LLC (the "Borrower"), has requested that the Public Finance Authority (the "Authority") issue bonds (the "Bonds") in an amount not to exceed \$5,500,000 to refinance certain outstanding indebtedness of the Borrower, which was previously incurred for the purpose of financing the cost of facilities for air cargo/freight operations (the "Facility") located at Harrisburg International Airport (the "Project"); and

WHEREAS, the Bonds or a portion thereof will be "private activity bonds" for purposes of the Internal Revenue Code of 1986 (the "Code"); and

WHEREAS, pursuant to Section 147(f) of the Code, prior to their issuance, private activity bonds are required to be approved by the "applicable elected representative" of a governmental unit having jurisdiction over the entire area in which any facility financed by such bonds is to be located, after a public hearing held following reasonable public notice; and

WHEREAS, the Project is located in the County; and

WHEREAS, the Bonds shall not be secured by any pledge of assets, moneys, revenues or taxing power of the County; and

WHEREAS, the members of the Board of Commissioners (the "Governing Body") of the County of Dauphin, Commonwealth of Pennsylvania (the "County") are the applicable elected representatives of the County; and

WHEREAS, the Borrower has requested that the Governing Body approve the refinancing of the Project and the issuance of the Bonds in order to satisfy the public approval requirement of Section 147(f) of the Code; and

WHEREAS, pursuant to Section 147(f) of the Code, the Susquehanna Area Regional Airport Authority (the "SARAA"), acting on behalf of the County, has, following notice duly given in the form attached hereto as Exhibit A (the "TEFRA Notice"), held a public hearing regarding the financing and refinancing of the Project and the issuance of the Bonds; and

WHEREAS, the Governing Body now desires to approve the financing and refinancing and the issuance of the Bonds; and

NOW, THEREFORE, BE IT RESOLVED BY THE ABOVE-NAMED GOVERNING BODY AS FOLLOWS:

- Section 1. The above recitals are true and correct.
- Section 2. The form and publication of the TEFRA Notice advertising the public hearing is hereby ratified and confirmed and the conduct by SARAA, as the designee of the County, of the public hearing under Section 147(f) of the Code hereby is ratified and confirmed.
- Section 3. The Governing Body hereby approves the issuance of the Bonds by the Authority for financing the Project. It is the purpose and intent of the Governing Body that this resolution constitute approval of the issuance of the Bonds by the applicable elected representative of the governmental unit having jurisdiction over the area in which the Facility is located, in accordance with Section 147(f) of the Code.
- Section 4. The officers of the Governing Body are hereby authorized and directed, jointly and severally, to do any and all things and to execute and deliver any and all documents that they deem necessary or advisable in order to carry out, give effect to and comply with the terms and intent of this resolution and the financing approved hereby.

MINUTES OF PUBLIC HEARING HELD BY AND THROUGH THE SUSQUEHANNA AREA REGIONAL AIRPORT AUTHORITY

Tom Peiffer, Deputy Director of Finance & Administration, of the Susquehanna Area Regional Airport Authority (the "Authority"), called the public hearing to order at 9:00 a.m., Mr. Peiffer made a presentation concerning the proposed project and financing, the subject of the hearing.

Mr. Peiffer presented the proposed project as described in the notice for the public hearing published in *The Patriot-News* on May 29, 2012. The project consists of the issuance by the Public Finance Authority of its Senior Airport Facilities Revenue and Refunding Bonds, Series 2012A (Tax-Exempt), in one or more series (the "Bonds") in the maximum principal amount not to exceed \$5,500,000. A portion of the proceeds from the sale of the Bonds will be loaned to Aero Harrisburg, LLC ("Aero") and used to refund certain outstanding indebtedness previously incurred by the Authority on behalf of Aero in connection with Aero's facilities located at Harrisburg International Airport ("HIA"). Aero has a long-term leasehold interest in a tract of land containing an approximately 75,750 square foot air cargo complex and ramp/parking area at HIA.

Scott R. Mehok, Esquire, of the law firm of Eckert Seamans Cherin & Mellott, LLC, stated that the public hearing was being conducted pursuant to the requirements of Section 147(f) of the Internal Revenue Code of 1986, as amended (the "Code") and that minutes of the hearing would be forwarded to the Dauphin County Commissioners. He described the necessity for an Elected Officials' approval under Section 147(f) of the Code, which approvals would be indicated by a Resolution adopted by the Dauphin County Commissioners. He further noted that the County Resolution was strictly for purposes of Section 147(f) of the Code and not for any other approval purposes such as local building permits and zoning.

It is hereby noted that no comments regarding the Project were made at the public hearing other than as referenced above and that no one from the public attended the hearing other than Mr. Peiffer and Mr. Mehok. There being no further comments, the public hearing was adjourned by Mr. Peiffer at 9:10 a.m.
