RESOLUTION NO. <u>AA-2013</u> COUNTY OF DAUPHIN

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF DAUPHIN, PENNSYLVANIA, APPROVING FOR SUBMISSION TO THE PENNSYLVANIA DEPARTMENT OF ENVIRONMENTAL PROTECTION FOR APPROVAL UNDER ACT 101 CERTAIN REVISIONS TO THE 2013 NON-SUBSTANTIAL PLAN REVISION AND ITS APPENDICES TO REFLECT RESPONSES TO COMMENTS PROVIDED BY THE DEPARTMENT DURING ITS REVIEW OF THE PLAN SUBMITTED ON SEPTEMBER 11

WHEREAS, the County of Dauphin, Pennsylvania (the "County"), is a county of the Commonwealth of Pennsylvania; and

WHEREAS, has adopted a Municipal Waste Management Plan under the authority of the Municipal Waste Planning, Recycling And Waste Reduction Act, 53 P.S. § 4000.101 et seq. (Act 101 of 1988); and

WHEREAS, on September 11, 2013 the County approved for submission to the Department of Environmental Protection ("PaDEP") a proposed Non-substantial Plan Revision, ("Plan Revision") for the review and approval of PaDEP pursuant to applicable law; and

WHEREAS, on September 12, 2013 PaDEP provided the County's consultants with preliminary comments regarding the Non-substantial Plan Revision in which certain revisions and corrections to the Plan were requested; and

WHEREAS, the County has Resolved to make such revisions or corrections as may be required by PaDEP to allow it to approve the Plan Revision;

NOW, THEREFORE, it is hereby RESOLVED by the Board of Commissioners of the County of Dauphin as follows:

1. The 2013 Non-substantial Plan Revision of the Dauphin County Municipal Waste Management Plan as developed by the County and submitted for review on September 11, 2013

shall be revised as shown on the version of the Plan Revision bearing the notation "670206 revised" and such revision shall be promptly submitted to the PaDEP in response to comments received as evidencing the County's intent to make necessary and appropriate changes to meet requirements of the PaDEP. If further revision is necessary to meet the requirements of the PaDEP as communicated to the County, such further revisions shall be made in any final Plan adopted by the Board of Commissioners as the County's Municipal Waste Management Plan.

2. Those Appendices of the 2013 Non-substantial Plan Revision, as submitted to PaDEP for review on September 11, 2013, shall be revised as shown on such Appendices appended to the Plan bearing the notation "670206 revised," consisting of a proposed Waste Management Ordinance and a proposed Rules and Regulations of the County Department of Solid Waste Management and Recycling and submitted to PaDEP for its review. If further revision of such Appendices is necessary to meet the requirements of the PaDEP as communicated to the County, such further revisions to any Appendices shall be made as part of any final Waste Management Plan adopted by the Board of Commissioners.
