RESOLUTION NO. 2013 - 8

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE COUNTY OF DAUPHIN, COMMONWEALTH OF PENNSYLVANIA, AUTHORIZING THE DISPOSAL OF CERTAIN SURPLUS PERSONAL PROPERTY

WHEREAS, the County of Dauphin (hereafter, County) is a political subdivision of the Commonwealth of Pennsylvania, and it is governed under The County Code (hereafter, Code), Act of August 9, 1955, P.L. 323, No. 130, as amended, 16 P.S. §101 et seq.; and

WHEREAS, under §203 of the Code, 16 P.S. §203, the County's corporate power is vested in a board of county commissioners (hereafter, Board); and

WHEREAS, under §1805(a) of the Code, 16 P.S. §1805(a), "[n]o personal property of the county * * * shall be disposed of by sale or otherwise, except upon resolution of the commissioners [;]"; and

WHEREAS, under §1805(a) and (b) of the Code, 16 P.S. § 1805(a) and (b), "[w]hen the commissioners approve a sale of such property * * *, they shall estimate the sale value of the entire lot to be disposed of, and, * * * [i]f the commissioners estimate the sale value of the personal property * * * at one thousand dollars (\$1,000) or more, the entire lot shall be advertised for sale, once * * * and sale of the property so advertised shall be made to the highest and best bidder [;]" and

WHEREAS, upon the recommendation of the County's Emergency Management Agency (hereafter, EMA), the Board has determined that certain personal property (hereafter, Property) is surplus, and that the entire lot of such Property is estimated to have a sale value of more than one thousand dollars (\$1,000); and

WHEREAS, the entire lot of such Property is identified on **Exhibit A** hereto; and

WHEREAS, such Property was advertised for sale on March 26, 2013, in The Patriot-News, which is a newspaper of general circulation in the County; and

WHEREAS, the County has received one bid in response to such advertisement, a true and correct copy of which is attached hereto at **Exhibit B**; and

WHEREAS, the Board wishes to sell the Property to the bidder because its offer is the highest and best bid.

NOW, THEREFORE, be it resolved by the Board as follows:


1. The Property shall be sold, as is, without warranty, to the highest and best bidder for the sum of Twenty-Thousand Two-Hundred Thirty-Seven (\$20,237.00) Dollars, which is the total sum of the bid on the entire lot. (See **Exhibit B.**)
2. The Purchasing Department and EMA are hereby authorized and directed to complete all paperwork necessary to effectuate the sale of the Property.
3. This Resolution was duly adopted by a motion of the Board.

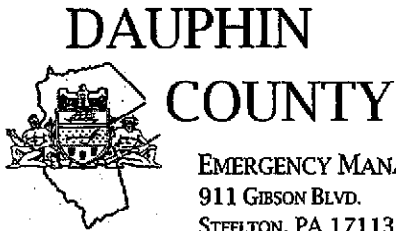
