RESOLUTION #17-2022

WHEREAS, Pennsylvania STEAM Academy Charter School (the "School"), a charter school duly organized and validly existing under the Pennsylvania Charter School Law (24 P.S. §17-1701-A, et seq.), and a Pennsylvania nonprofit corporation has determined to finance a project consisting of: (i) acquiring a portion of the School facility and other real property constituting the School's campus, including educational and parking facilities; (ii) acquiring furniture, fixtures and equipment, including certain capital improvements to the School; (iii) refinancing or repayment of outstanding lines of credit, if deemed necessary or desirable by the School; (iv) funding a debt service reserve fund for the Obligations (hereinafter defined) and capitalized interest thereon, if necessary; (v) paying certain costs of issuance relating to Obligations (hereinafter defined); and (vi) other lawful and permissible purposes (the "Project"); and

WHEREAS, the School desires to finance costs of the Project by incurring debt to be evidenced by one or more series of bonds or notes (the "Obligations") to be issued by the Upper Dauphin Industrial Development Authority (the "Issuer") for the benefit of the School in an aggregate principal amount not to exceed \$12,000,000; and

WHEREAS, the Issuer and the School intend that the interest on the Obligations will be qualified for exemption from federal income taxation under provisions of Section 103 of the United States Internal Revenue Code of 1954, as amended (the "1954 Code"), including amendments made by the Internal Revenue Code of 1986 (the "1986 Code"), the 1954 Code and the 1986 Code being

referred to herein as the "Code" (such obligations are referred to herein as "tax-exempt obligations") and

WHEREAS, Section 147(f) of the Code requires that the governmental unit having jurisdiction over the area in which a project is located give its approval for the project to have the benefit of using tax-exempt obligations after a public hearing on the matter.

NOW THEREFORE, be it resolved by the Board of County Commissioners of the County of Dauphin, Pennsylvania, as follows:

SECTION 1. A duly advertised public hearing having been held on the matter on June 28, 2022 at 10:00 a.m. at which any and all comments from members of the public were heard and considered, the Board of County Commissioners of this County hereby approves the use of tax-exempt obligations for the benefit of the School in financing the Project.

SECTION 2. The approval given in Section 1 of the Resolution is limited to the purposes of Section 147(f) of the Code and does not, and shall not be construed to, constitute an approval of the Project for any other purpose nor shall the County be obligated in any way with respect to the Obligations, the Project, or the School.

SECTION 3. All action of this Board taken in conformity with the intents and purposes of this Resolution is ratified, confirmed, and approved in all respects.

SECTION 4. All resolutions or parts of resolutions, insofar as such shall be inconsistent herewith, shall be and the same expressly are repealed.
