RESOLUTION NO. 19-2022

RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE COUNTY OF DAUPHIN, PENNSYLVANIA APPROVING THE OPERATION OF THE CENTRAL PENNSYLVANIA FILM COMMISSION OFFICE TO BE ADMINISTERD BY THE FILM, ARTS, AND TOURISM SPECIALIST (FACTS) NONPROFIT ORGANIZATION REGARDING FILM ACTIVITIES WITHIN DAUPHIN COUNTY AND SUPPORTING APPLICATION BY FACTS ON BEHALF OF THE OFFICE FOR MEMBERSHIP TO THE ASSOCIATION OF FILM COMMISSIONERS INTERNATIONAL

WHEREAS, the County, with a more than 235-year history, exists as a great place to live, work, visit and explore; and

WHEREAS, the County's landscape boasts parks and historic landmarks along with a diverse population and multicultural community; and

WHEREAS, tourists and visitors are drawn to the County year-round and from all over to experience events and attractions located within the County; and

WHEREAS, the County does not currently have a designated film/television/media office or special representative on film/television/media matters within the County; and

WHEREAS, Film, Arts, and Tourism Specialist (FACTS) is a 501(c)(3) entity within Dauphin County seeking to promote and expand the film/television/media industry within the county; and

WHEREAS, the County desires to designate the Central Pennsylvania Film Commission as a program administered by FACTS and the office within the County to promote the County as a location for the development of film, video, and multimedia production; and

WHEREAS, the County envisions the Central Pennsylvania Film Commission as an office run through FACTS to attract film production to the County; provide resources for potential filmmakers, vendors, crewmembers and other participants; and coordinate the efforts of public and private stakeholders as it relates to film production.

NOW THEREFORE, be it resolved by the Commissioners of the County of Dauphin, Pennsylvania, as follows:

- 1. The County approves the creation and operation of the Central Pennsylvania Film Commission as the film office within the County to be administered and managed by the Film, Arts, and Tourism Specialist (FACTS) 501(c)(3) organization (Exhibit A).
- 2. The County designates the Central Pennsylvania Film Commission office as the representative to the film industry for the County area.
- 3. The County supports the mission of the Central Pennsylvania Film Commission to provide leadership and direction on film, video and multimedia production in the County.
- 4. The County supports the submission by FACTS of the application for membership to the Association of Film Commissioners International (AFCI) by the Central Pennsylvania

Film Commission to be accompanied by the AFCI Official Government Endorsement Form, attached hereto as <u>Exhibit B</u>.

Central Pennsylvania Film Commission (CPFC) Next Steps

A program of the Film, Arts, Culture & Tourism Specialist (FACTS), a 501c3 nonprofit organization.

The Central Pennsylvania Film Commission would be authorized to:

- To provide leadership and strategic direction on issues related to the film, music recording and production, and entertainment industries
- Foster the identification and marketing of ideal sites for filming, film production, music recording and production, and other entertainment purposes
- Provide leadership for the development of a Film, Music, and Entertainment Strategic Plan for Dauphin County.
- Make recommendations regarding policy and procedural changes that would improve Dauphin County's business climate to grow the film, music, and entertainment industries.
- Serve as ambassadors to Dauphin County and the Central Pennsylvania Region (York, Lancaster, Lebanon, etc.)
- Develop an annual program in furtherance of the mission
- Undertake all necessary and appropriate activities pursuant to the mission, subject to budgetary constraints.
- Facilitate industry training and education based in Dauphin County.
- Provide leadership and strategic direction to attract motion picture, television, interactive game, and animation productions to Dauphin County.

Phase 1 (Initiation)

- 1. Get a solidified written endorsement from the County Commissioners to establish the **Central Pennsylvania Fim Commission (CPFC)**, embracing the partnership with FACTS. FACTS will work closely with Dauphin County to develop a strategic plan that will help retain and attract even more entertainment projects, jobs, and businesses throughout the county.
 - **FACTS** is the appointed organization that will house the **CPFC**, modeled after https://www.filmerie.com/
 - FACTS is responsible for seminars, workshops, continual education, and all other facets aligned with strategic growth and quality control.
 - www.factspa.com
 - All partnering companies, vendors, or individuals endorsed by CPFC would first be vetted through FACTS and uphold quality standards.
- 2. Fundraise for \$6000 for application submission and professional development, as outlined here.
 - Funding can be allocated through Gaming Grant Earnings.
- 3. Submit Application to AFCI https://afci.org/join-afci/
 - Submit the completed form along with your payment to the AFCI office (email completed form to Marjorie Galas, SVP Membership & Industry Relations at Marj.Galas@afci.org)
 - The AFCI Executive Office holds the right to review all submitted applications for Business Affiliates as well as Film Commissions and Film Liaisons.
 - Notice of new members, including Film Commissions, Film Liaisons and Business Affiliates will be posted to all current AFCI members via a Newsletter, allowing for a 30-day comment period from our membership
 - Following the 30-day membership review, if no concerns are raised, the new member is considered fully inducted.

Phase 2 (Sustainability/ Growth)

- 1. Align with Visit Hershey Harrisburg to carve out \$200k budget to financially sustain the CPFC as outlined in the <u>budget</u>.
 - o If full \$200k is not allocated, determine other source funding.
- 2. Hire/ Onboard two key positions- Film Commissioner (Director) & Liaison (Production Coordinator)
 - o Film Commissioner- Johntrae Williams
 - o Film Liaison- Kelly Summerford
- 3. Establish an advisory board to provide strategic direction, marketing, and site selection assistance that leverages state incentives and local assets to attract film, television, music recording and production, interactive gaming, animation, and other projects to Dauphin County.
 - Advisory Board provides non-binding strategic advice to the FACTS Board of Directors. The advisory board does not have authority to vote on corporate matters or bear legal fiduciary responsibilities.
 - Strategic partners including but not limited to:
 - Government Officials
 - IATSE union heads
 - Financers
 - Film/ Music Production Companies
 - Heads of College Universities/ Technical Schools
 - Chamber of Commerce
 - Film Festival Experts
 - Board members are volunteer, however, are still able to profit from potential projects as long as there is transparency concerning their involvement, and potential Employers are made aware of various options and vendors.
- 4. Gather inventory of:

Phase 3 (Marketing/Promotion)

- 1. Initial Press Release-

- 3. Establish a marketing and web presence which presents a unified front for our region that appeals to film industry prospects.

- 4. Complete production of the, "Film Central PA" promo video (As outlined in the Gaming Grant)
 - House the video on the landing page

Phase 4 (Capacity Building)

- 1. Continued Professional Development for Staff Members
 - o Film Commisioner and Liason must attend AFCI University

- 1. Establish **FEA (Film & Entertainment Alliance)** an Inter-Governmental Agreement (IGA) aligning the key stakeholders of 8 surrounding counties (York, Lancaster, Lebanon,etc), giving ordinance for the **Central Pennsylvania Film Commision** to provide the following services:
 - o Facilitate permitting processes for film and production on its behalf
 - o Assist partnering municipalities with the identification and marketing of ideal sites for filming, film production, music recording and production, and other entertainment purposes. In turn, building and managing a location database
 - o Provide leadership and strategic direction in attracting motion picture, television, interactive game, and animation productions to Dauphin County.
