RESOLUTION #4/2019

**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS
OF THE COUNTY OF DAUPHIN, PENNSYLVANIA**

AND NOW, The Board of County Commissioners of the County of Dauphin makes the following Resolution for the purposes therein set forth.

WHEREAS, the Board of Commissioners is committed to promoting the musical, enological and culinary arts of our County; and

WHEREAS, the Board of Commissioners is committed to promoting the County of Dauphin as a great place to live, work and visit; and

WHEREAS, it is the Policy and Practice of the County of Dauphin to ordinarily prohibit the consumption and or possession of alcoholic beverages on premises which it owns, leases and or occupies; and

WHEREAS, the Dauphin County Department of Parks and Recreation, desires to host the 12th Annual Music & Wine Festival at Fort Hunter Park on Saturday, June 8 and Sunday, June 9, 2019 from 4:00pm to 9pm; the 7th Annual Brew Fest at Fort Hunter Park on Saturday, July 20, 2019 from 3:00pm to 7:00pm; Friends of For Hunter Farm to River, Sunday, August 18, from 5:00pm to 8:00pm and the 13th Annual Jazz & Wine Festival at Fort Hunter on Friday, September 6, Saturda, September 7 and Sunday, September 8, 2019 from 4:00 pm to 10:00 pm.

WHEREAS, the events will feature, in addition to performing artists, twelve (10) Central Pennsylvania wineries; and

WHEREAS, said wineries will be seeking to obtain and will have obtained by the dates hereinabove set forth, two "special two-day and three-day permits" from the PLCB, to allow for tasting


and sale of wine during the course of the Music & Wine Festival and Jazz & Wine Festival; and a one day Brew Fest and Farm To River.

WHEREAS, the wineries have agreed to and do accept responsibility for insuring that the rules and regulations, appurtenant to the Special Permit, to be issued by the PLCB, are fully complied with.

NOW, THEREFORE, be it hereby resolved by the Board of County Commissioners of the County of Dauphin, that the general County policy and practice of prohibiting the consumption and or possession of alcoholic beverages on County owned and or leased premises, is hereby suspended, solely for Fort Hunter Park on Saturday, June 8 and Sunday, June 9, 2019 between the hours of 4:00 P.M. to 9:00 pm; Saturday, July 20, 2019 between the hours of 3:00 P.M. to 7:00 P.M.; Friends of Fort Hunter Farm to River, Sunday, August 18 from 5:00pm to 8:00pm; and Friday, September 6, Saturday, September 7, and Sunday, September 8, 2019 between the hours of 4:00 P.M. to 10:00 P.M. for the purposes of further promoting the four events to be held at Fort Hunter Park, namely Music & Wine Festival; Brew Fest; Farm to River; and Jazz & Wine Festival, together with the promoting the arts, business and community of Dauphin County.
