RESOLUTION OF THE BOARD OF COMMISSIONERS OF DAUPHIN COUNTY, PENNSYLVANIA APPROVING COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG-CV) ROUND 2 COVID RECOVERY SMALL BUSINESS AND NONPROFIT ASSISTANCE GRANT AWARDS AND AUTHORIZING GEORGE H. CONNOR TO EXECUTE SUBRECIPIENT AGREEMENTS ON BEHALF OF THE COUNTY OF DAUPHIN

RESOLUTION NO. 1-2021

WHEREAS, under the Coronavirus Aid, Relief, and Economic Security Act (CARES Act), the Secretary of the U.S. Department of Housing and Urban Development (HUD) has allocated a second tranche of funding to the County of Dauphin Pennsylvania, to implement additional Community Development Block Grant COVID Assistance Programs (CDBG-CV); and

WHEREAS, the County of Dauphin submitted, and HUD approved, the County's 2019 Amended Consolidated Action Plan, which accounts for appropriated uses of the second tranche of CDBG-CV funds; and

WHEREAS, the Dauphin County Board of Commissioners previously approved the additionally amended 2019 Action Plan, which included the allocation of \$1,148,664 for additional CDBG-CV COVID Recovery Small Business and Nonprofit Assistance Grants; and

WHEREAS, the Dauphin County Office of Community and Economic Development solicited additional grant applications from Dauphin County small businesses and nonprofit organizations through a public application process; and

WHEREAS, the Dauphin County Office of Community and Economic Development thoroughly reviewed each application and determined eligibility based on requirements established HUD; and

WHEREAS, the Dauphin County Office of Community and Economic Development has presented the first round of applicants that meet all eligibility requirements for the CDBG-CV Round 2 COVID Recovery Small Business and Nonprofit Assistance Grant Program and hereby recommends that grants be awarded to the entities and in the amounts listed on Exhibit "A"; and

WHEREAS, due to the continued need for rapid deployment of critical funding to small businesses and nonprofits impacted by COVID-19, the Board of Commissioners seeks to expedite the administrative process to deploy assistance in a timely manner.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Dauphin County, Pennsylvania, that:


1. The subrecipients and corresponding award amounts listed in Exhibit "A" are hereby approved in an amount totaling \$1,041,484.05.

3. A similar resolution is expected to be considered in the future until the remainder of CDBG-CV funds allocated for small business and nonprofit assistance are fully expended.


